PUBLIC HEARING (Council Bill 2021-1906)

Council Bill 202-1906 creates the Urban Center – Mixed Use (UC-MU) Zoning District and rezones multiple parcels from Residential Three-Unit Medium Density (R3-M) and Oakland Public Realm Sub-district D (OPR-D) to the newly created Urban Center – Mixed Use (UC-MU) Zoning.

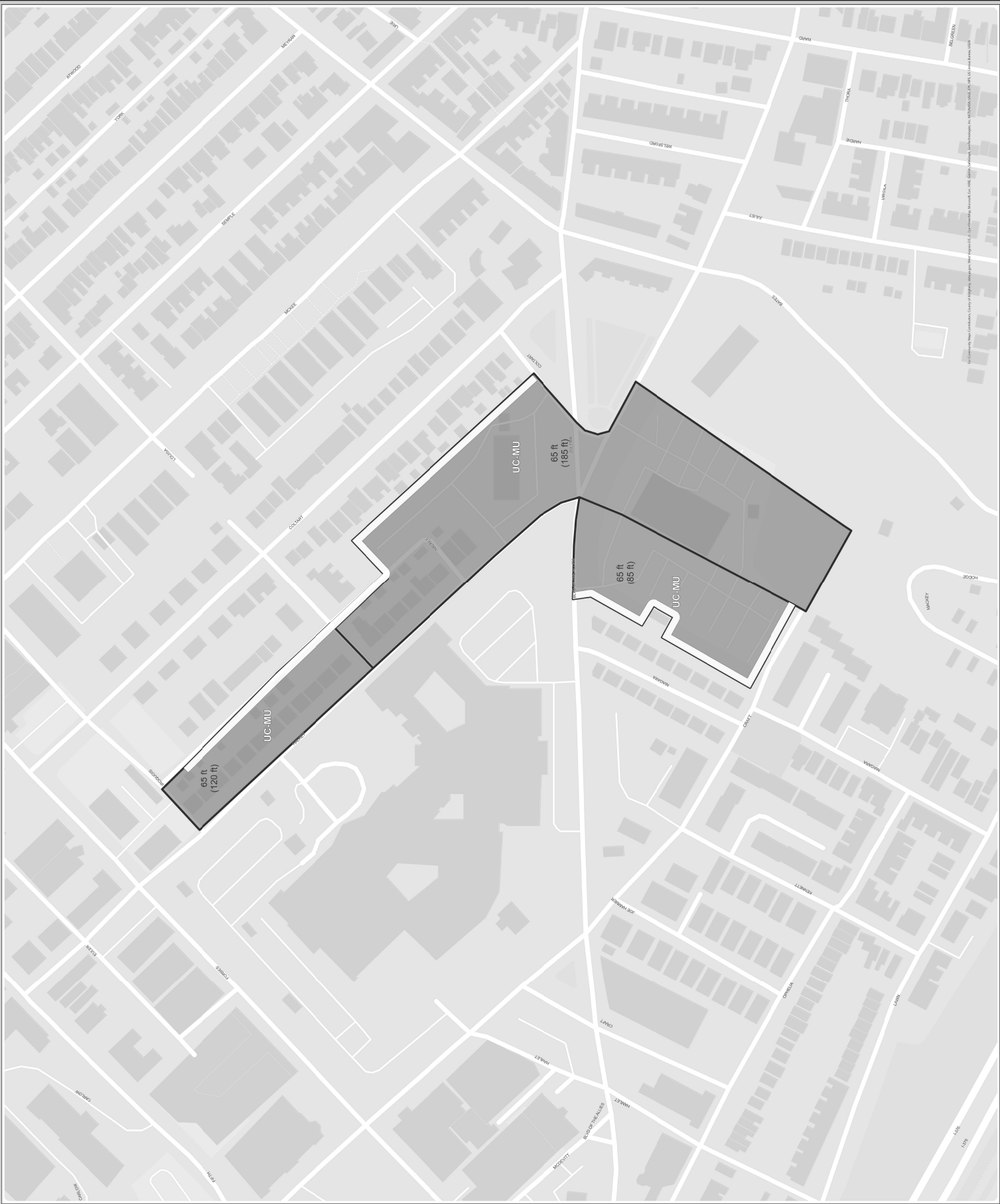

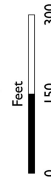
