#### Here's where we are on Oakland Public Realm E (OPR-E)

On Tuesday, February 8, Mayor Ed Gainey requested a second 30-day continuance on the Oakland



Public Realm Subdistrict E (OPR-E) proposed zoning ordinance. According to the Mayor's Office Press Release, the administration will consider the zoning in a phased approach, and "continue to advocate for a solution that prioritizes equitable development, inclusionary zoning, food access, and aligns with the priorities in the Oakland Plan."

Until the public hearing before the Planning Commission (now scheduled for Tuesday, March 8 at 2:00 p.m.), residents are encouraged to leave their feedback on the proposal at the EngagePGH website, engage.pittsburghpa.gov/OPR-E. ## Celebrating Black History Month



Charles "Teenie" Harris (1908–1998) was the leading

photographer for *The Pittsburgh Courier* from 1941 to 1975. Nicknamed "One Shot" for his quick ability to photograph his subjects, Teenie captured the daily lives of Black Americans, including athletes, celebrities, and civil rights leaders. His work is featured year-round in the Carnegie Museum of Art, now with a new interactive exhibit. The City-County Building is also featuring a tribute to Teenie Harris this month with an exhibit of both his negatives and his impact on Black history in Pittsburgh. #### Senior Agining-in-Place Homeowner Assistance Resources are Still Available

Any Oakland homeowner over the age of 55 who is at or below 80% of area median income may be eligible to receive up to \$22,500 for

home repairs and modifications when they join the Oakland Community Land Trust (CLT). By joining the CLT, participants continue to own and live in their home; and ensure their home will remain homeowner-occupied in perpetuity. The CLT is growing! OPDC just welcomed a new family to Coltart Street in January.
